- Follow MGKVP standards and policies.

### 4. Exclusive Partnership Terms

- IGP CAMPUS is the sole exclusive partner in Sri Lanka.
- MGKVP will not appoint any other institution during the MoU period.
- Exclusive rights depend on performance and adherence.

5. Duration

Effective from 01 December 2025 for Five (5) Years. Renewable by mutual written agreement.

6. Financial Terms

Financial arrangements will be detailed in a separate Agreement.

7. Confidentiality

All exchanged information shall remain confidential unless mutually approved for release.

8. Dispute Resolution



Disputes will be resolved first through discussion, then lawful measures if needed.
